The seminar will discuss safe and efficient traffic stops to include right side approaches. In addition, officer safety issues will be discussed with emphasis on contact and cover principles. A practical exercise will be conducted utilizing "red-handled gun" scenarios. Finally, an update will be provided on Ohio's CCW law. Officer safety is everybody's business; it is a survival "attitude" that must be developed, practiced and rehearsed.

Mr. Healy was a career law enforcement officer who had been a member of the law enforcement community for over 29 years. For over 24 years, Mr. Healy had been a member of the Ohio State Highway Patrol and was the coordinator of the Highway Patrol's Traffic Drug Interdiction Team (TDIT). Mr. Healy has a Bachelor's degree from Ohio University and a Master's degree from Central Michigan University, **Mr. Healy** is a graduate of the Southern Police Institute's Administrative Officers Course at the University of Louisville. He has served as an instructor for the Northwestern University Traffic Institute (NUTI), the International Association of Chiefs of Police (IACP), the Drug Enforcement Administration, and the Drug Interdiction Assistance Program. Mr. Healy is a former adjunct professor of constitutional law at Ohio University. He has also served as an expert on search and seizure while serving on various search and seizure instructional panels at the Ohio Attorney General's Conference on Law Enforcement for over five years. He is the Director of the North Coast Polytechnic Institute.
