“Expert Testimony in Court”



A crime or crash occurs and a highly trained law enforcement officer responds to investigate. A proper investigation, analytical protocol, and expert opinion are arrived at. Based upon the expert police officer's analysis criminal charges are filed and a court date is set. This is only the beginning for the law enforcement expert witness. It is no longer important that management, the prosecutor or peers agree with the findings, now the challenge is to convince the jury the expert opinions are correct.

In today's legal environment, expert witnesses are subjected to discovery, close personal and professional scrutiny of their opinions and vigorous cross-examination. It is incumbent upon the law enforcement expert to fully understand the legal system that governs expert testimony. As a part of this seminar, attendees will participate in role playing in mock trial situations. A highly experienced defense/civil attorney will assist in the role-playing and answer questions.

The expert's opinion is only as good as the foundation upon which it is built and how well it can hold up in court. This seminar is a must for law enforcement officers who testify in court regarding any facet of criminal investigation. Attorneys routinely attend training seminars to learn how to cross-examine witnesses, the law enforcement officer should have similar education.

NOTE: Each student should bring the best written example of expert criminal or traffic case work. Some students will be selected to be cross-examined in a role playing format based upon these casework examples.
