About the Course: Will Meet 2017 CPT Training



In 2017, the AG and OPOTA announced that 20 hours of Continuing Professional Training (CPT) will be required for all law enforcement officers. To obtain reimbursement, sixteen (16) of the hours must be in critical subject matters; the remaining four (4) hours can be conducted on general law enforcement topics. NCPI will be conducting a 2 day seminar by providing 16 hours of training in the following topics:

Six (6) hours of training will be on “Legal Updates” (2 hours to meet “critical subject matter” & 4 hours to meet “general education”): This block of instruction will discuss search & seizure and laws of arrest issues and an update on new statutes. The search & seizure block will discuss the Fourth Amendment, the exclusionary rule, why cops stop people, the length of an investigative detention and the 7 search warrant exceptions with emphasis on stop & frisk, search incident to arrest, motor vehicle probable cause, plain view, plain feel, inventory & consent. The laws of arrest block will discuss Ohio Revised Code Chapter 2935 with emphasis on citations/ summonses, misdemeanor & felony arrests. A review of U.S. Supreme Court and Ohio Supreme Court decisions will also be provided on each of the topics. Finally, new legislation & statutes affecting law enforcement will be reviewed. It should be noted that two (2) of these hours will meet the “critical subject matter” training and four (4) of these hours will meet the “general education” training.

Four (4) hours of “critical subject matter” training will be on “Procedural Justice & Police Legitimacy”: This block of instruction will explore the processes officers can use to treat citizens fairly and respectfully, while strengthening their department’s relationships with their communities. Students will explore techniques they can use to create an organizational culture that fosters a partnership with the public which leads to a safer work environment. (Taught from a mandatory lesson plan prepared by OPOTA).

Six (6) hours of “critical subject matter” training will be on “Trauma Informed Policing”: Trauma has real and serious consequences, and law enforcement professionals in this day and age need to have an understanding of trauma-informed approaches to those whom they serve. The goal of this six (6) hour interactive block of instruction will be to increase our understanding of trauma, create an awareness of the impact of trauma on behavior, and help develop trauma-informed responses. The class also explores issues of vicarious trauma within the law enforcement community, and provides suggestions on how to promote sustainable practices that might mitigate the effects of vicarious trauma. (Taught from a mandatory lesson plan prepared by OPOTA).

NCPI will not be providing training on the final four (4) hours of “Practical Use of Force” which is a part of the 2017 “critical subject matter” training. This 4 hour block of instruction must be instructed by OPOTA “certified force” instructors. Also, the training must meet the OPOTA requirements of 1 instructor for every 10 students. So, my training staff will not be able to teach any of the practical training due to the instructor/student ratios and the cost & difficulty in getting the proper number of instructors for each seminar. It is my recommendation that departments across the State conduct this training with their own in-house force instructors or partner up with another department in your area to get this done. You will have all year to get in the practical use of force training for your officers.

ABOUT THE INSTRUCTORS:



William D. Healy was a career law enforcement officer who had been a member of the law enforcement community for over 29 years. For over 24 years, Mr.

Healy had been a member of the Ohio State Highway Patrol and was the coordinator of the Highway Patrol’s Traffic Drug Interdiction Team (TDIT). He also served as a Lieutenant and Highway Patrol training coordinator at the Ohio State Highway Patrol Training Academy for over five years. Mr. Healy has a Bachelor’s degree from Ohio University and a Master’s degree from Central Michigan University. Mr. Healy is a graduate of the Southern Police Institute’s Administrative Officers Course at the University of Louisville. He has served as an instructor for the Northwestern University Traffic Institute (NUTI), the International Association of Chiefs of Police (IACP), the Drug Enforcement Administration, and the Drug Interdiction Assistance Program. Mr. Healy is a former adjunct professor of constitutional law at Ohio University. He has been certified as a Police Instructor through OPOTA for over 28 years and has trained tens of thousands of law enforcement officers in a variety of disciplines. He is the Director of the North Coast Polytechnic Institute, a criminal justice training company in North Ridgeville, Ohio.

NCPI will be using various 2nd instructors for this training. These instructors must either be OPOTA certified crisis intervention, SAMSA GAINS Center, NAMI CIT, or critical incident stress management program trainers.
