## About the Course: 2026 CPT Training Requirements



Pursuant to Ohio Revised Code 109.803, the Ohio Peace Officer Training Commission (OPOTC) is required to set a minimum number of hours for continued professional training (CPT) if there is supporting funding. The Ohio General Assembly has once again provided funding for CPT hours in 2026. The OPOTC Commission has identified eight (8) hours of mandatory training; the remaining 16 hours consists of optional training topics that will need to be pre-approved by OPOTA. In 2026, NCPI will be officering the following CPT training:

**Day One – 8 Hours – Four (4) hours on Legal Aspects of Confessions and then Four (4) hours on Civil Liability related to motor vehicles, illegal arrest/search and failure to train.**

**Day Two – 8 Hours – Two (2) hours on Evidence Handling and Property; Two (2) hours on Mental Health Awareness Issues; One (1) hour on Officer Safety – Distractions that affect Safety; One (1) hour on Public Video and Audio recording of Cops; and Two (2) hours on Impacts of Women in Policing on Female Offenders/Victims**

**Day Three – 8 Hours – (Mandatory day); OPOTA is requiring eight (8) hours on the following 5 topics:**

2 hours	<b>Legal Updates</b>
1 hour	<b>Missing Persons (part of the 3 hour legal update requirement)</b>
2 hours	<b>Communications</b>
2 hours	<b>Compliance and Control Tactics</b>
1 hour	<b>Firearms</b>
