## Search & Seizure/Search Warrants

Nov 2 Cost: \$90 Host: Westlake PD

This course is designed to provide information to criminal prosecutors and law enforcement officers concerning search and seizure with emphasis upon conducting warrantless searches. The seven exceptions to the warrant rule will be discussed in detail to include: stop and frisk, search incident to arrest, probable cause, plain view, plain feel, inventory and consent. Information will also be provided on the seizure of people, abandonment of property, protective sweep and utilization of a narcotics canine to conduct sniffs of vehicles and objects. In addition, the requirements for completion of a search warrant and related warrant forms will be discussed. The requirements for a nighttime search warrant and a no-knock search warrant will be provided. Numerous court decisions at both the federal and state levels will be reviewed. **6.25 hours CLE credits will be available for attorneys as approved by the Ohio Supreme Court**

**Topics to be Covered:**

Determining and applying A, B, and G stiffness coefficients – CRASH3 algorithm. Crash tests and their sources, including how to research crash test data and the stiffness coefficients from the National Highway Traffic Safety Administration and Neptune Engineering; Full overlap vs. partial overlap of contact damage; Energy translation to speed calculations, including the most commonly applied mathematical calculations to translate energy into speed; Narrow object principles and their formulae. This topic will delve into the complexity of apply narrow object collision damage from poles, or other small profile objects; Vehicle Damage Analysis – understanding vehicle behavior in collisions; Basic Strength of Measurement – Hooke’s Law and Young’s Modulus regarding strength of materials; mechanical testing used by ASTM to evaluate strength, deformation & energy values.



Thanks for your support and encouragement as I head into my 13th year of providing training services to law enforcement throughout Ohio. Hopefully, next year with the casinos getting started, OPOTA will have funds available for CPT mandated training. As with your budgets, 2011 has been a lean year for NCPI. In an effort to reduce costs, we will be forwarding this newsletter through e-mails and will post in on the web page. In an effort to address additional training initiatives, I have worked with my training staff to develop some new schools that should be successful. We have listed the “new schools”

that we will be offering to the right of this column. All of these new schools will be instructed by veteran law enforcement officers from various agencies throughout Ohio. I believe they will be received positively by students across the State. Finally, officer safety should be a topic of discussion and training for 2012. So far, 2011 has been a terrible year for law enforcement deaths. Of the 50 officers killed by gunfire so far this year, which is a 32% increase from the same time last year, at least 19 were victims of ambush or surprise attacks. Attorney General Eric Holder has launched a broad review of officer safety in the wake of rising gunfire fatalities, citing the need for more research (and maybe training) to help officers survive violent encounters. Be ever vigilant!!

## PEALS 2012

### Police Executive Administrative and Leadership School

This **three-week (15 day)** school addresses the need for intensive management curriculum that is cost effective. The PEALS school is designed to enhance the operational and the conceptual leadership skills of current and future “top dogs” within the law enforcement community. The training program is designed to provide substantive lecture presentations with practical exercises and problem solving project work to confront the issues critical to law enforcement managers and executives. The curriculum will include training in human resource management, labor relations/grievance handling, discipline, Garrity & Weingarten rules, managing and motivating a diverse employee population, contract negotiation, administrative investigations, community policing, core values, training and organizational viability, CALEA, personal financial planning, civil liability, leadership, administrative law, managing change in organizations, strategic vision and planning, ethics, professional stops and racial profiling, and 2 new segments “Professional Media Relations” and “Preparing for and Participating in Executive Assessment Centers.” We continue to enhance this program based on critiques and aim for excellence. We have trained over 200 police executives as we head into our 11th PEALS class. On Sept 7, Westlake PD will host "Police Writing". The course will include training in the use of punctuation, capitalization, use of numbers, abbreviations, plurals, possessives, spelling, grammar, word usage, composition and forms germane to law enforcement. Numerous practical writing assignments will be conducted utilizing videotapes and scenarios as a guide. Also, discussion will be generated on common errors associated with police reports.

## Legal Updates \$90

SEALE Academy/Bedford PD will host this eight (8) hour legal updates seminar on Sept 14. This seminar will be of benefit for every law enforcement officer. ### How to Prepare Search Warrants & Affidavits

Training will be provided on the legal aspects of search warrants/affidavits with a thorough review of constitutional law issues and case law decisions. Training will also be provided on how to complete a search warrant affidavit to include the writing of thorough and complete probable cause statements. Discussion will also be centered on the actual service of a search warrant with emphasis on the amount of force that can be used to service the warrant and the difference between daytime/night-time search warrants and knock & announce versus no knock search warrants. In addition, discussion will be conducted on the return of the warrant and the completion of the inventory/receipt portion of the search warrant process. Finally, a practical exercise will be conducted on the completion of the search warrant affidavit.
