### “Corrections In-Service”



The Ohio Minimum Jail Standards require that staff assigned to the jail duties in 12 day or 12 hour facilities receive training within the first year of assignment. A minimum of sixteen hours of training is mandated to include topics of security concepts, suicide prevention, first aid, CPR, and unarmed self defense. This one (1) day seminar, when combined with departmental unarmed self defense and CPR/First Aid Certification, fulfills the requirements of the Administrative Code and is approved by the Bureau of Adult Detention.
