

About the course:

"Laws of Arrest & OVI Laws and Standardized Field Sobriety Testing (SFST) Review"



The purpose of this eight (8) hour seminar is to provide advanced training in laws of arrest principles, OVI laws and Standardized Field Sobriety Testing (SFST) review. Two (2) hours of this seminar will meet the mandatory Continuing Professional Training (CPT) requirements for 2009. One of the leading causes of civil liability and damage awards for law enforcement agencies and officers is in the area of false

arrests. Law enforcement agencies have an affirmative duty to train their officers. Advanced training in laws of arrest principles, OVI laws, SFST procedures and constitutional case law practices may minimize the potential for costly and time-consuming lawsuits.

About the Instructor

Mr. William Healy was a career law enforcement officer for over 29 years. He retired from the Ohio Highway Patrol after serving for 25 years. While on the Patrol, he served for 5 years as a manager/instructor at the Highway Patrol Academy. Mr. Healy has a Bachelor's Degree from Ohio University and a Master's Degree from Central Michigan University in General Administration, and currently serves as the Director of North Coast Polytechnic Institute. Mr. Healy is a graduate of the Southern Police Institute's Administrative Officer's Course at the University of Louisville, and has served as an instructor at the Northwestern University Traffic Institute (NUTI), the International Association of Chiefs of Police (IACP), the Ohio Attorney General's Conference on Law Enforcement, the Drug Enforcement Administration, and the Drug Interdiction Assistance Program. He is a life-time certified instructor with the Ohio Peace Officer's Training Council (OPOTC).
