Officer Safety and Survival “FAST” Firearms, Arrest and Survival Tactics

Throughout the United States, hundreds of law enforcement officers are killed in the line of duty each year and thousands more are injured as a result of violent physical confrontations with assailants. The FBI’s Uniformed Crime Reporting (UCR) teletypes and bulletins provide an ever present reminder to all of us how dangerous and costly the job can sometimes become. For any law enforcement professional who has attended a funeral for a slain brother or sister officer, this reminder can be a tremendous “wake up call” to be ever vigilant and alert in the performance of our duties. This three (3) day “officer safety and survival” course is designed to heighten the awareness of law enforcement professionals to be ever vigilant and alert while performing their duties. The instructors combined have over 50 years of law enforcement experience and over 30 years of law enforcement “officer survival” training experience. The course utilizes lecture presentations, slide presentations and practical exercises in firearms training and red-handled gun scenarios to develop an officer survival attitude in each student. Officer safety is everybody’s business; it is a survival “attitude” that must be developed, practiced and rehearsed.

About the instructors:



Toby Smith is a career law enforcement officer who has been employed by the Ohio State Highway Patrol for over fifteen years. Currently, Toby is a Sergeant assigned to the Mansfield Highway Patrol Post as a 1st line supervisor. During his career, Toby had been assigned to the Ohio State Highway Patrol Training Academy for over 4 years where he was a self defense tactics instructor. In addition, Sergeant Smith was in charge of all Highway Patrol officer safety and survival courses. Sergeant Smith has trained thousands of law enforcement officers in street survival techniques.

William D. Healy was a career law enforcement officer who was a member of the law enforcement community for the past 29 years. For the past 25 years Mr. Healy had been a member of the Ohio State Highway Patrol and was the Commander of the Highway Patrol's Traffic Drug Interdiction Team (TDIT) a program out of Columbus, Ohio. He also served for over five years as a manager/instructor at the Highway Patrol Academy. Mr. Healy has a Bachelor's Degree from Ohio University and a Master's Degree from Central Michigan University in General Administration. He currently serves as the Director of NCPI. Mr. Healy is a graduate of the Southern Police Institute's Administrative Officer's Course at the University of Louisville.
