About the Course: Should Meet 2016 CPT Training



In light of recent events, the Presidential Task Force on 21st Century Policing examined a number of high-profile issues surrounding strengthening public trust and fostering strong relationships between local law enforcement and the communities that they protect. The 21st Century police force will require new skills and approaches to strengthen public trust and strategies for effective crime reduction. In April 2015, Ohio Attorney General Mike DeWine released the “Advisory

Group on Law Enforcement Training’s” report related to law enforcement training throughout the State of Ohio.

As a result, the AG and OPOTA announced that 11 hours of Continuing Professional Training (CPT) will be required in 2016 for all law enforcement officers. To obtain reimbursement, nine (9) of the hours must be in critical subject matters; the remaining two (2) hours can be conducted on general law enforcement topics. This seminar will only conduct 9 hours of training on the critical subject matter topics.

Four (4) critical hours of training will be on “Community Police Relations – Procedural Justice, Implicit Bias and Blue Courage”. This block of instruction will define the term blue courage and discuss each of the nine modules related to blue courage. In addition, the terms practical wisdom, procedural justice and implicit bias will be defined. Each of the four components and five critical dimensions in procedural justice will be reviewed. Also, the method in which recruitment & hiring, community policing and training can impact implicit bias will be discussed. Practical synergistic exercises in these areas will be utilized to enhance the training.

Two (2) critical hours of training will be on “Crisis De-Escalation with Emphasis on Mental Illness”. Personal safety is “your” business. Most cops would rather be “talking” than “fighting”. It is your obligation to develop “verbal judo” skills and develop a disarming dialogue that will assist you in minimizing potential for physical injury or harm. In addition, government services throughout this nation have had tightened budgets that have shuttered mental health clinics and put emotionally disturbed people on the streets. We in law enforcement must stay trained on tactics for dealing with the mentally ill.

Two (2) critical hours of training will be on “Constitutional Use of Force”. This block will discuss liability as it relates to both deadly and non-deadly force. Constitutional case law decisions from the U.S. Supreme Court and the Ohio Supreme Court related to use of force issues will be reviewed. Methods to minimize liability will be also be discussed. Synergistic exercises related to case law decisions will be utilized in class.

One (1) critical hour of training will be on “Human Trafficking”. This block will define the term human trafficking and discuss each of the different types of crimes related to human trafficking. In addition, a review of the federal Trafficking Victims Protection Act (TVPA) law will be discussed. Finally, key questions that officers should ask to communicate with and investigate human trafficking crimes will be reviewed.

The final two (2) hours of training relates to “general law enforcement” topics. However, the Lorain PD has decided not to conduct any general law enforcement training. Their plan is to have their officers attend various in-service training programs or take the final 2 hours through E-OPOTA. Officers attending any of the Lorain PD training programs will need to have 2 hours of training in other law enforcement topics throughout the year.

ABOUT THE INSTRUCTOR:



William D. Healy was a career law enforcement officer who had been a member of the law enforcement community for over 29 years. For over 24 years, Mr. Healy had been a member of the Ohio State Highway Patrol and was the coordinator of the Highway Patrol’s Traffic Drug Interdiction Team (TDIT). He also served as a Lieutenant and Highway Patrol training coordinator at the Ohio State Highway Patrol Training Academy for over five years. Mr. Healy has a Bachelor’s degree from Ohio University and a Master’s degree from Central Michigan University. Mr. Healy is a graduate of the Southern Police Institute’s Administrative Officers Course at the University of Louisville. He has served as an instructor for the Northwestern University Traffic Institute (NUTI), the International Association of Chiefs of Police (IACP), the Drug Enforcement Administration, and the Drug Interdiction Assistance Program. Mr. Healy is a former adjunct professor of constitutional law at Ohio University. He has been certified as a Police Instructor through OPOTA for over 28 years and has trained tens of thousands of law enforcement officers in a variety of disciplines. He is the Director of the North Coast Polytechnic Institute, a criminal justice training company in North Ridgeville, Ohio.
