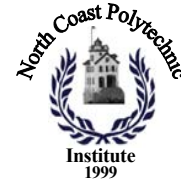

“**Search and Seizure**” is designed to provide information to criminal prosecutors and law enforcement officers concerning search and seizure with emphasis upon conducting warrantless searches. The seven exceptions to the warrant rule will be discussed in detail to include: stop and frisk, search incident to arrest, probable cause, plain view, plain feel, inventory and consent. “**Laws of Arrest**” provides advanced training in laws of arrest principles and constitutional case law decisions to enable law enforcement officers

to more effectively and efficiently perform their duties. One of the leading

causes of civil liability and damage awards for law enforcement agencies and officers is in the area of false arrests. Law enforcement agencies have an affirmative duty to train their officers. Advanced training in laws of arrest principles and constitutional case law practices may minimize the potential for costly and time-consuming lawsuits. Numerous court decisions at both the federal and state levels will be reviewed.
