Information will also be provided on the seizure of people, abandonment of property, protective sweep and utilization of a narcotics canine to conduct sniffs of vehicles and objects. In addition, the requirements for completion of a search warrant and related warrant forms will be discussed. The requirements for a nighttime search warrant and a no-knock search warrant will be provided. Numerous court decisions at both the federal and state levels will be reviewed.
